Subsequent to that disclosure, and in accordance with Regulation 30 read with Schedule III of the Regulations, we hereby inform you that, at the meeting of the Board of Directors held on November 14, 2025, Mr. Surinder Paul Kanwar in response to the unsigned, undated, and anonymous letter and to the points raised by Mr. Sameer Kanwar, Joint Managing Director regarding the photocopy of the passport, enclosed in the said anonymous letter, has given a written representation to the Board stating that the anonymous letter lacks verifiable particulars and appears to originate from a fictitious address. He accordingly recommended that the Board not to take cognizance of the anonymous communication.

Mr. Kanwar also informed the Board that he received a communication from the Regional Director's office, Ministry of Corporate Affairs, requesting information concerning his citizenship status. He has furnished the required details to the Regional Director's office.

Mr. Kanwar has requested the Regional Director's office to provide a copy of the underlying complaint basis which the communication was issued by the Regional Director. He has also raised questions regarding his jurisdiction/competence in respect of the subject matter and reserved his legal rights in this regard.

Further, he confirmed that he has not received any additional correspondence from the Regional Director's office to date. Should any further communication be received, he will promptly apprise the Board.

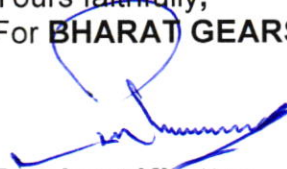
